FOOD VENDORS CONTRACT

1. Full size Spaces (20' x 30') are numbered 1 thru 38 and each are **\$190.00** per weekend.
2. **10' x 25'** spaces numbered 39 thru 50 are **\$105.00** per weekend. (Pickups & Pop-ups only)
(Food Vendors spaces will be assigned depending on the size and needs of your vehicle.)
3. **The Following Items are Mandatory:**
 - Sellers Permit
 - Liability Insurance
 - Health Department Permit

Note: Photocopies of all permits and insurance to be included with contract ,(MUST BE RECEIVED BY JUNE 15, 2024.)
4. The terms of this contract are for August 2nd, 3th, & 4th 2024 If you are unable to be there all three days, please discuss with **Renea Sutcliffe, Dealer Chairman. 805-929-2783.**
5. Set up & Dismantling – Vendors may begin to set up by 8:00 AM, and have everything ready to go by Show Time Friday, August 2, 2024. Vehicles will be prohibited in the Show Area once the Show Starts. (You may also set up Thursday afternoon, August 1st, if that is more convenient). You will be unable to leave until 5:00 PM on Friday and Saturday, and 4:00 PM on Sunday, when the show closes.
6. No electricity is provided. Water faucet and restrooms available in area.
7. No pets or alcohol allowed on campus; Service dogs OK, NHS is a tobacco free zone.
8. No bicycles, mini-bikes, or skateboards.
9. A watchman is provided Thursday, Friday, and Saturday nights.
10. Cancellations – must be submitted to Renea Sutcliffe, Dealer Chairman, a minimum of sixty (60) days prior to the show date. Consideration will be given to emergency situations. If cancellation of space is received prior to the show date with enough time to obtain another food Vendor the Show Committee will determine the amount of refund. **NO REFUNDS AFTER JULY 15, 2024, unless due to hardship.**
